Your past activities tell me that you are a dedicated warrior for the Pro-Life cause and a champion for saving the lives of our precious unborn babies from the horror of abortion.

So I think you will be pleased to know that in June of last year AMERICANS UNITED FOR LIFE (AUL) won a landmark victory in the Supreme Court against the state of California that protects the free speech and freedom of religion rights of Pro-Life Americans.

I'll tell you more about this amazing landmark victory in a moment.

AMERICANS UNITED FOR LIFE has been involved in some 30 cases that made it to the Supreme Court since our founding in 1971.

Now we're back in the Supreme Court again on another key case — to defend the legal right of states to block **Planned Parenthood** from having access to Medicaid block grant funds.

In all, **Planned Parenthood** receives more than \$543 MILLION from the U.S. government (taxpayer money), much of it through Medicaid block grants to the states. **Planned Parenthood** is America's #1 abortion business — committing upwards of 320,000

abortions per year at its abortion mills.

It also has a gruesome baby organ and body parts harvesting business, where the organs (such as beating hearts, livers, lungs, eyes, and other vital organs) are cut out of the baby during a late-term abortion or even just after a live baby is born. The baby's organs are then sold to the highest bidder.

**Planned Parenthood's** baby organ harvesting operation is a multi-million-dollar business. The babies in a later abortion feel unimaginable pain as their bodies are torn apart by the abortionist's scalpels, scissors, and tools during the extraction of the baby's organs.

This baby organ harvesting business is a big reason over a dozen states so far have chosen to block **Planned Parenthood** from receiving access to Medicaid funds because they don't want Medicaid funds (taxpayer funds) to be used for abortion, or for Planned Parenthood's baby torture and organ harvesting business, or for the tens of millions of dollars Planned Parenthood spends every election season to elect pro-abortion candidates and defeat Pro-Life candidates.

**Planned Parenthood's** lawyers have challenged the right of states to block Planned Parenthood from having access to Medicaid block grant funds.

my name is Catherine Glenn Foster. I am a Pro-Life attorney. I am also President and CEO of AMERICANS UNITED FOR LIFE.

AUL's legal team has been involved in every abortion-related case before the U.S. Supreme Court since *Roe v. Wade* in 1973 — thirty cases that have made it to the Supreme Court and dozens more in America's lower federal courts.

AUL crafts model Pro-Life legislation for states and Congress to act on — legislation designed to survive legal challenges to the Supreme Court.

Just since 2011, state legislatures have passed almost 500 Pro-Life laws, most of them modeled after legislation crafted by AUL's legal team. These laws include . . .

- . . . Ending taxpayer funding for Planned Parenthood.
- . . . Banning abortion after five months of pregnancy.
- . . . Banning dismemberment abortions (tearing the baby apart with tools).
- . . . Banning gender-selection abortions or abortions done on Down's syndrome children or based on race.
- . . . Requiring parental consent for minors, and many more.

Our legal team then works with Pro-Life states to defend these state laws in the courts. And, of course, all these laws are being challenged in the courts by Planned Parenthood and the abortion industry.

So we write model laws designed to survive court challenges. Then our legal team defends these laws when challenged in the courts. AUL is the only Pro-Life organization doing this work.

AUL's legal team is actively fighting these court battles — all the way to the Supreme Court. Mr. Rogers, AUL is the abortion industry's worst nightmare.

For example, in June of 2018, we had a major victory in the Supreme Court that overturned a California law called the “Reproductive FACT Act” that required Christian Pro-Life pregnancy centers to post notices and to inform pregnant women who visit these Pro-Life centers that the state of California offers free abortions.

Our legal team immediately swung into action and helped take this case all the way to the Supreme Court — where the Justices ruled (in a 5-4 decision) that the state of California cannot force Pro-Life doctors and health providers to advertise and promote abortion.

this ruling will help us overturn similar pro-abortion laws other states have adopted or threatened to adopt.

Right now, we have our case before the Supreme Court that could end hundreds of millions of dollars of yearly taxpayer funding for Planned Parenthood. IF we prevail at least a dozen states are poised to block **Planned Parenthood** from getting any of the Medicaid funds allocated to these states.

But these federal court cases are very costly, especially at the Supreme Court level. The only way we can fund them is with voluntary donations from wonderful Pro-Life Americans, like you.

Half of Planned Parenthood’s \$1.2 BILLION annual budget is supplied by taxpayers — more than \$543 MILLION per year. If we can block Planned Parenthood’s access to Medicaid grant money at the state level, this could cost Planned Parenthood hundreds of millions of taxpayer dollars each year and save the lives of untold numbers of babies.

And it would also put a big dent in Planned Parenthood’s election war chest. Every election season, Planned Parenthood spends tens of millions of dollars on attack ads against Pro-Life elected officials and candidates. In fact, Planned Parenthood is arguably the radical anti-Christian Left’s most powerful political lobby, with a \$1.2 BILLION annual budget, almost half of it funded by taxpayers (by you).

Of course, Planned Parenthood will say it does not use taxpayer money to pay for abortions or its massive ad campaigns to defeat Pro-Life candidates. Nothing could be further from the truth!

Your taxpayer money helps pay **Planned Parenthood’s** overhead: rent and buildings, salaries, phones, utilities, etc. So, the more we can cut off its access to taxpayer money, the more damage we can do to their abortion business, and the more lives of babies we can save. And the more we can cut off a major source of funding for the anti-Christian Left’s political ad campaigns.

Not only is Planned Parenthood America’s biggest abortion business (committing upwards of 320,000 abortions every year), but Planned Parenthood is America’s #1 promoter of abortion. Most public schools use sex-ed curricula written by Planned Parenthood, which promotes promiscuity for children as young as kindergarten. It’s truly is an evil organization in every way.

That’s why it’s so important we win this case, now in the Supreme Court.

AUL urgently needs donations to help us fight and win this battle in the Supreme Court and keep our

**P.S.** it's unusual for AMERICANS UNITED FOR LIFE to be involved in two major Supreme Court legal battles in the same year. We're also working on numerous cases in lower federal courts that could end up before the Supreme Court.

These legal battles have stretched AUL's resources to the breaking point. There's no other way to say it: Our bank account is down to its final few dollars.

It would be tragic if we were forced to scale back our efforts due to being out of funds, especially as we enter the final stage of this crucial Supreme Court fight. Nor do I want to pare back our efforts in our lower federal court cases — because these cases will likely be in the Supreme Court this year.

AUL has been tearing apart at the Supreme Court's catastrophic *Roe v. Wade* ruling in 1973 that overturned Pro-Life laws in all 50 states and resulted in the deaths of 60 MILLION unborn babies in their mother's womb. We've chipped away at *Roe v. Wade* by crafting model legislation and working with the states to enact hundreds of laws that now protect both women and their precious unborn children — laws ENDING late-term abortions in the 18 states that ban abortions after 20 weeks and many other laws aimed at real healthcare, not funding the abortion industry with our taxpayer dollars. We then defend these laws in the courts — all the way to the Supreme Court. 

# IMPORTANT SUPREME COURT CASE LEGAL ACTION SURVEY

**HORROR SUMMARY:** Undercover investigative videos by the Center for Medical Progress reveal that one of Planned Parenthood's major businesses is to slice out the internal organs of babies during an abortion and then sell the baby's internal organs to highest bidder. **HORROR SUMMARY:** Planned Parenthood officials and "doctors" are captured on video laughing and joking about how rich they are getting from their baby organ harvesting and selling business. One boasted that she hopes to make enough money from this so she could "buy a Lamborghini" — a sports car that costs \$200,000 to \$400,000. She said this while sipping a glass of wine and eating a salad.

**ISSUE SUMMARY:** Planned Parenthood performs upwards of 320,000 abortions per year at their 750 clinics nationwide and charges mothers \$450 on average to abort their babies. In addition, Planned Parenthood receives more than \$543 MILLION per year from the U.S. government (taxpayers). Planned Parenthood's annual budget is \$1.2 BILLION. So almost half of Planned Parenthood's revenue comes from taxpayers.

**LEGAL ACTION SUMMARY:** Since 1971, AMERICANS UNITED FOR LIFE has been involved in 30 cases that made it to the Supreme Court. In our latest victory, the Supreme Court ruled in June of 2018 that the state of California cannot force Pro-Life pregnancy centers to advertise and promote abortion. AUL was also in the Supreme Court, arguing the federal law gives broad authority to the states in how it uses and manages Medicaid block grant funds and has the authority to deny Planned Parenthood access to Medicaid block grant funds. That case would enable more than a dozen states to block Planned Parenthood from receiving Medicaid block grant funds, which has the potential to deprive Planned Parenthood and the abortion industry of tens of millions of dollars in taxpayer-funds every year.

QUESTION #5: What is your opinion of AUL's 48-year history of legal and legislative action aimed at putting the abortion industry out of business and saving more than 1,000,000 lives of unborn babies that are snuffed out by abortion every year?

**PROJECT SUMMARY:** Very few hospitals perform abortions, as abortion violates a hospital's primary mission, which is to save lives. So the overwhelming majority of abortions are performed in unregulated abortion mills. That's why a major focus of AUL has been to require abortion mills to abide by the same health and safety standards required of all medical facilities. The result has been the shutting down of hundreds of abortion mills by health and safety inspectors and/or because abortion mills cannot afford to meet basic health and safety standards. So today you can find only one abortion clinic in Missouri, Mississippi, North Dakota, South Dakota and Wyoming, just two abortion clinics in Utah and Kentucky, and just 3 in Alaska, Oklahoma, Arkansas, Idaho, and South Carolina. Because of AUL's legal and legislative actions, it's getting much tougher to open an abortion mill or to keep them open. As a result, the lives of untold numbers of babies have been saved.

QUESTION #6: What is your opinion of AUL's legal and legislative strategy aimed at requiring abortion mills to abide by basic health and safety standards — the result of which has been the shutting down of hundreds of abortion mills across America?

**STRATEGY SUMMARY:** AUL's team of Pro-Life attorneys carefully crafts Pro-Life legislation for Congress and states to adopt that are designed to survive challenges in the federal courts, including the Supreme Court. Since 2011, state legislatures have passed close to 500 Pro-Life laws, most of them modeled after model legislation crafted by AUL's legal team. Examples of legislation passed include . . .

- Banning abortion after five months of pregnancy.
- Banning dismemberment abortions (tearing the baby apart with tools).
- Requiring abortion mills to show the mother an ultrasound video of the baby in her womb before an abortion can be performed.
- Banning gender-selection abortions or abortions done on Down's syndrome children.
- Banning abortions based on race.
- Requiring abortion mills to file reports on any physical or mental health issues that result from abortions performed at the facility.
- Requiring parental consent for minors.
- And many more.

AUL's team of attorneys then helps the states defend these laws in the federal courts, all the way up to the Supreme Court.
