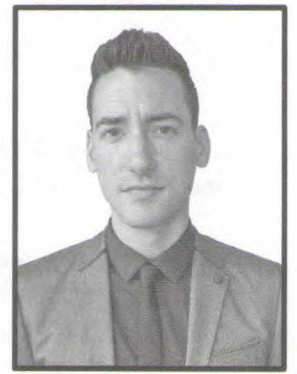


# I've been found guilty and fined \$2.3 million for exposing Planned Parenthood. You won't believe how I've been railroaded . . .

As you can imagine, being exposed as a blood money profiteer peddling body parts made Planned Parenthood furious.

And Planned Parenthood filed a retaliatory lawsuit against me for pulling the mask off of them.

They were very crafty in their lawsuit and sued me in San Francisco where they'd likely get a friendly judge and venue -- which is exactly what happened.

→ **From the very beginning of the trial, the presiding judge, Judge Orrick, stacked the deck against me.**

Judge Orrick issued ruling after ruling that took away my legal defenses to the charges against me. He wouldn't even let the jury watch the videos Planned Parenthood was suing for!

Early on, Judge Orrick issued an unconstitutional gag order stopping me from releasing my most damning videos, calling the videos of Planned Parenthood's abortion crimes being freely discussed in open spaces "private" and "confidential".

This was an unprecedented attack on the First Amendment. Courts never impose blanket gag orders on the work of investigative journalists like me. But Judge Orrick did.

After that, Judge Orrick wrongly refused to instruct the jury on the clear First Amendment law that protects the investigative journalism I did into Planned Parenthood's crimes.

And even worse, he repeatedly told the jury that the First Amendment didn't apply at all in my case!

That's 100% wrong!

However, the straw that broke the camel's back was when Judge Orrick **ORDERED THE JURY** to find me guilty on several counts and said the jury could only determine the extent of the "damages."

*Can you believe that???*

Sadly, this is all too believable once you know Judge Orrick's background.

You see, Judge Orrick is well-known to be a pro-abortion activist judge.

Prior to sitting on the bench, Judge Orrick opened and funded a Planned Parenthood clinic in San Francisco -- in cooperation with Tom Steyer's wife!



Judge Orrick has extensive personal and professional relations with Planned Parenthood and should never have been allowed to oversee a trial where Planned Parenthood was one of the parties.

✦ **In fact, Judge Orrick's wife is a pro-abortion activist who has publicly denigrated me and supported Planned Parenthood.** ✦

Mrs. Orrick has claimed that CMP's work consists of "heavily edited videos by a sham organization run by extremists who will stop at nothing to deny women legal abortion services."

***This is flat-out false.***

The undercover videos The Center for Medical Progress has released have shown the true face of Planned Parenthood...

...the barbaric, baby body part selling side that pro-abortion forces have desperately tried to keep hidden from the American public.

The truth is that Judge Orrick went into this case with an axe to grind against me and a bias in favor of Planned Parenthood. He was the perfect judge to be in the pocket of Planned Parenthood.

And in the end he delivered Planned Parenthood the verdict it so desperately wanted.

I was hit with **\$468,000** in compensatory damages that are **TRIPLED** under the federal civil RICO act to \$1.4 million.

The defense was socked with **\$870,000** in punitive damages.

All told, I'm looking at a massive and massively unjust nearly **\$2.3 million judgment** against me and CMP.

I'm immediately filing an emergency appeal to reverse this decision and I need your help to fund my legal defense.

As bad as this entire ordeal has been, there's also been a silver lining in that Planned Parenthood has finally had to admit the truth of my journalistic work...

Indeed, during the trial Planned Parenthood made no effort to attack the veracity of the undercover videos I made.

→ They had no choice because what I uncovered was Planned

Parenthood's dark underbelly and its crimes related to selling the body parts of aborted babies was TRUE!

This trial allowed us expose emails from Planned Parenthood Gulf Coast abortion leadership in Houston, TX showing that they were willing to sell fetal livers for \$750 each.

Planned Parenthood national leadership testified that certain abortion techniques -- including ones that are the hallmark of the criminal partial-birth abortion procedure -- are totally acceptable in Planned Parenthood's eyes to obtain marketable body parts.

And we heard directly from the disgraced fetal trafficking company Advanced Bioscience Resources, that they remain partnered with Planned Parenthood Pacific Southwest, and that they regularly receive intact fetuses for organ harvesting.

On point after point, Planned Parenthood had to admit devastating facts that show that it was deeply involved in the illegal harvesting of aborted babies to sell their body parts.

The facts revealed at trial show that in reality, Planned Parenthood are the guilty ones. And public officials are taking note.

Just this year, President Trump's Health and Human Services Department began the administrative defunding of Planned Parenthood, for the first time stripping over \$60 million in federal taxpayer subsidies away from this unrepentant abortion factory.

And in Congress, after over a year of comprehensive investigation, the House Select Investigative Panel on Infant Lives and the Senate Judiciary Committee made criminal referrals against Planned Parenthood to the FBI and U.S. Department of Justice.

**Now, Planned Parenthood is under federal criminal investigation -- an investigation that could produce charges any day now.**

Indeed it would be hard for Planned Parenthood to escape justice because their business partners admitted guilt in a \$7.8 million settlement with the Orange County, CA District Attorney. And he said my reporting prompted the case.

Planned Parenthood's litigation against me has been nothing but retaliation for exposing what they so desperately wanted to



keep hidden. And now their existence is on the line.

Just 1 hour of my videos brought Planned Parenthood to its knees...

...but I have another 200 hours of undercover footage -- footage that could END Planned Parenthood.

That's why Planned Parenthood threw everything they have at me to take me out in this federal lawsuit.
