



He must have known after a month on the job that there was no collusion with Russia by any member of the Trump campaign. Why didn't Mueller tell this to the American people a year and a half ago instead of allowing this cloud of suspicion to hang over the Trump Presidency for two years?

To me, this proves the corrupt intent of the Mueller investigation. They were out to get President Trump – if not for colluding with Russia, for something else – any crime they could find.

But they found nothing.

Now it's time to fully prosecute everyone involved in this attempted COUP D'ETAT – this assault by Team Obama against our Constitutional Republic.

My name is Bob Barr. I am a former U.S. Attorney – also a former member of Congress.

I am also the co-founder and Chairman of LIBERTY GUARD. With more than 100,000 members and supporters, LIBERTY GUARD fights for the rule of law and honesty in government because we believe corruption in government is the single greatest threat to liberty.

We don't want America to become a corrupt one-party state, like Venezuela – which is what almost happened on November 8, 2016 . . . if **Hillary Clinton** had won the Presidency instead of **Donald Trump**.

They were treating Donald Trump as though he were an enemy of the United States – like ISIS.

And then after Trump won the election (much to their shock) they continued to use the awesome powers of the FBI, CIA and NSA to try to topple our duly elected President – to conduct what was, in effect, a COUP.







Fabricated Evidence to Trigger Investigation of Trump

The evidence is now overwhelming that **President Obama's** CIA Director **John Brennan**, National Intelligence Director **James Clapper**, FBI Director **James Comey**, FBI Deputy Director **Andrew McCabe**, Attorney General **Loretta Lynch** and a cabal of anti-Trump FBI agents led by **Peter Strzok** used the awesome powers of the **CIA**, **FBI** and **NSA** to spy on the Trump campaign for the purpose of concocting smears against **President Trump**, leaking to the media, and thereby sinking the campaign of the GOP nominee for President and tilting the 2016 Election to **Hillary Clinton**.

They did this by using an opposition research document prepared by the Clinton campaign, known as the "**Steele Dossier**," as the evidence the Department of Justice presented to the secret Foreign Intelligence Surveillance Court (FISA Court) to conduct a secret counter-intelligence investigation against candidate Trump and his campaign team.

The preposterous claim was that **Donald Trump** was an agent of the Russian government. The so-called "Steele Dossier" was the centerpiece of the phony evidence presented to the FISA Court to get this counter-intelligence investigation going against President Trump.

The source of the "Steele Dossier" was never explained to the FISA Court – or the fact that it was an opposition research document created by the Hillary Clinton campaign.

The Mueller Report concludes that the most damaging claims in the "Steele Dossier" are false or likely false. **Christopher Steele** is a former British spy. From 2004 to 2009 he headed Britain's MI6 Russia Station. So his connections in the Kremlin are extensive.

As part of his Dossier on Trump, his sources include what he calls Source A, described as "a senior Russian Foreign Ministry figure." Source B was "a former top-level intelligence officer still active in the Kremlin." And Source E, he says, was "an ethnic Russian" and "close associate of Republican US presidential candidate Donald Trump."

New York Times Admits Team Clinton's Fabricated Evidence Against Trump Likely Supplied by Kremlin

Steele himself admitted in his testimony to Congress under oath that he cannot verify the most sensational salacious material in his Dossier on Trump. *The New York Times*, in a news article dated April 19, 2019, now admits that the most sensational claims in the Dossier implying that Trump is an asset of the Kremlin and detailing his alleged romps with prostitutes while in Moscow appear to be fiction and are likely disinformation supplied by Russian intelligence, designed to sow chaos and discord in the American political system.

"How the dossier ended up loaded with dubious or exaggerated details remains uncertain," writes the Times. "[A] possibility — one that Mr. Steele has not ruled out — could be Russian disinformation. That would mean that in addition to carrying out an effective attack on the Clinton campaign, Russian spymasters hedged their bets and placed a few land mines under Mr. Trump's presidency as well."

The Times further wonders: "Mr. Mueller's report contained over a dozen passing references to the document's claims but no overall assessment of why so much did not check out."

But if Steele always considered the Dossier raw intelligence and merely cause for further investigation, it's curious that he was talking to multiple news outlets about his Dossier prior to the election. He gave an interview to *Mother Jones* about it in October 2016. That doesn't sound like someone who is handling raw intelligence. It sounds like someone helping to dump anti-Trump smears days before the Election.

But this was the document, much of it now proven to be fiction, that the Obama Administration used starting in May 2016 to secure four separate warrants from the secret FISA Court to conduct total surveillance on **Donald Trump** and his campaign.

This secret counter-intelligence investigation continued against **Donald Trump** after he was elected and became the foundation for triggering the Special Counsel Investigation, led by former FBI Director **Robert Mueller**, who was also a close friend of fired FBI Director **James Comey**.

Obama's FBI Anti Trump Investigation

The code name Obama's FBI gave to its investigation of Trump in 2016 was "CROSSFIRE HURRICANE."

What does this tell you about the mindset behind launching this investigation into **Donald Trump** in May 2016 -- when it became clear Trump would be the Republican nominee for President?

The purpose of creating "CROSSFIRE HURRICANE" was obviously to create chaos, to disrupt, to confuse, to destroy Donald Trump and his campaign – not to find out the truth about anything. It was a dirty tricks operation carried out by Obama's FBI, CIA, NSA and Department of Justice against candidate Trump.

"CROSSFIRE HURRICANE" is the type of code name you give to a military operation – especially one that involves psy-ops, deception and ambush. Obama's FBI and Justice Department claim they didn't know how anti-Trump Christopher Steele was – the compiler of the infamous Dossier. They also claim they did not know Steele's employer, **Fusion GPS**, was the opposition research firm hired by the **Hillary Clinton** campaign to compile the Dossier.

But we know this is a lie because the wife of **Bruce Ohr**, #4 at Obama's Justice Department, worked at Fusion GPS. Her name is **Nellie Ohr**. She was the one primarily tasked with directing Steele's activities.

She handed Steele's Dossier off to her husband at the FBI, who helped get the counter-intelligence investigation rolling against Donald Trump and his associates.

Bruce Ohr told Congressional investigators that he clearly informed the FBI that his wife, **Nellie Ohr**, and Steele both worked for Fusion GPS. Hillary Clinton's campaign hired Fusion GPS by laundering payments through their law firm, Perkins Coie, in order to conceal the payments and thus blur the origin of the Dossier.

Bruce Ohr testified that he first met with Steele about Trump on July 30, 2016. The following day, he met with both Andrew McCabe (#2 at the FBI) and FBI lawyer Lisa Page. They put Ohr in touch with FBI Russian counterintelligence head **Peter Strzok**, who later got fired for his anti-Trump text messages to his mistress **Lisa Page**. Strzok was cheating on his wife with Page. He was also a key player behind the Trump investigation.

In August 2016, Ohr says he briefed top Justice Department officials, including **Andrew Weissmann**, then the top fraud official at Obama's Department of Justice; Bruce Swartz, who headed DOJ's international operations; and Zainab Ahmad, a terrorism prosecutor. Both Ahmad and Weissmann ended up working for Robert Mueller's Russia-Trump investigation, along with Strzok, until he was fired for his virulently anti-Trump text messages to Lisa Page.

Strzok even boasted in one text message about this counter-intelligence investigation being the "insurance policy" in case Trump managed to win the election. Strzok sent this text to Page on Aug. 15, 2016, in response to Page's concern that Trump might win the election.

Here's what Strzok told his mistress: "I want to believe the path you threw out for consideration in Andy's office — that there's no way he gets elected — but I'm afraid we can't take that risk," he wrote. "It's like an insurance policy in the unlikely event you die before 40."

The "Andy" mentioned in the text is FBI #2 Andrew McCabe, a key player in this "insurance policy."

The grievous crime here is the Obama Justice Department, FBI, CIA and NSA knowingly used tainted, biased intelligence (now much of it proven false) to get the ball rolling on the investigation of Trump.

Fake News Steele Dossier Manipulated to get FISA Warrant

The law and Department of Justice rules require that FISA Court warrant applications include all relevant facts, including exculpatory facts, and that all information presented to the Court is verified as accurate. Clearly, these rules were not followed when the FBI applied for warrants to spy on Donald Trump and his campaign.

Former FBI Director **James Comey** admitted in sworn testimony to the Senate Judiciary Committee on June 8, 2017, that material contained in the Steele Dossier was known to be both "salacious" and "unverified."

But the FBI did not make this clear to the FISA Court when they applied for warrants to conduct total surveillance on Trump and his team. Nor did they explain to the FISA Court that the main evidence justifying these surveillance

warrants was a thinly sourced piece of opposition research created by the Hillary Clinton campaign.

These deeply corrupt FISA warrant applications using foreign sources, including likely disinformation supplied by Russian intelligence, rumor and hearsay, as part of an opposition research document created by the Hillary campaign were approved by Obama's Department of Justice and FBI officials at the highest levels before being submitted to the FISA Court.

Obama's #2 at the FBI **Andrew McCabe** boasts in his book and in numerous TV interviews that he was able to get the ball rolling on triggering the Special Counsel Investigation against President Trump before McCabe was fired for his lies to Justice Department investigators about leaking confidential FBI information to the media.

McCabe told CBS's *60 Minutes* that he took steps to make sure the "Russia Collusion" investigation could not be stopped.

"I was very concerned that I was able to put the Russia case on absolutely solid ground in an indelible fashion that, were I removed quickly or reassigned or fired, that the case could not be closed or vanish in the night without a trace," he told CBS. "I wanted to make sure that our case was on solid ground and if somebody came in behind me and closed it and tried to walk away from it, they were not be able to do that without creating a record why they'd made that decision."

McCabe also confirmed that he spoke with senior DOJ officials regarding the potential invocation of the 25th Amendment, which allows the vice president and a majority of the Cabinet to remove the president from office if they think he's unfit. McCabe added that then-Deputy Attorney General Rod Rosenstein also suggested that he or other officials wear a wire and secretly record Trump.

Obama Holdover Appoints Mueller to Head Probe of Trump Day After Trump Rejects Mueller Application to Run FBI. Mueller Also Best Friends with Comey.

Rod Rosenstein, another holdover from the Obama Administration, was the one who initiated the Special Counsel Investigation after then-Attorney General **Jeff Sessions** was duped into recusing himself, leaving Trump to fight off Obama's Deep State holdovers on his own.

On May 16, 2017, Rosenstein walked **Robert Mueller** into the Oval Office, recommending President Trump hire Mueller to replace the fired James Comey as FBI Director. Mueller interviewed for the job with Trump, who decided against appointing Mueller as his new FBI Director. Trump felt there were too many conflicts of interest – most notably Mueller's close friendship with the fired **James Comey**.

The very next day, on May 17, Rosenstein appointed Mueller as Special Counsel to lead the two-year fraudulent investigation into "Trump-Russia Collusion."
