This show of support will demand the Attorney General open a full investigation of unethical activity and political bias by bad actors within the Department of Justice and FBI...

...and that he recommend action be taken against any and all Deep State officials and employees who abused their power in targeting President Trump.

I can't explain it all in this letter. In fact, we're finding so much corruption in our nation's capital even former Federal Prosecutors like me can barely keep up.

I explain, in more detail, in the enclosed **EMERGENCY SURVEY** I must ask you to immediately fill out.

Make no mistake. Deep State operatives at the highest levels -- not the rank and file -- within the FBI and Justice Department engaged in a left wing attempt to nullify the results of a lawful national election.

Just look at what sick depths they sunk to in order to smear, defame, and even try to imprison, President Trump!

- 1) Former FBI Acting Director Andrew McCabe has admitted to a plot, hatched with Deputy Attorney General Rod Rosenstein, to spy on and try to remove President Trump.

- 5) When it became clear Trump might win, Strzok met with officials in the office of FBI Deputy Director Andrew McCabe to come up with an "insurance policy" to ensure Trump would not remain as President should he win.
- 6) Strzok and Special Counsel Robert Mueller tried to get former Trump National Security Advisor Michael Flynn to incriminate Trump. Strzok had also conducted the questioning of Hillary aides Huma Abedin and Cheryl Mills, but he refused to have them charged with perjury even after the CIA proved to him they lied under oath.

7) Investigators are supposed to be impartial and have no ties to the case or witnesses. However, when it came time to hire investigators to probe President Trump's campaign and recommend criminal charges, four of the investigators hired by Mueller donated to Hillary's 2016 campaign.
