

Dear American Voter,

Will you stand with Senator Ted Cruz and us and stop massive voter fraud from corrupting the 2020 elections?

There's no time to spare. Join our important lawsuits now.

Because as Senator Cruz wrote in his letter, the Left is fighting to **MAKE VOTER FRAUD EASIER!**

The Left is working hard to...

**** REPEAL** Voter ID laws

**** STOP** jurisdictions from cleaning their voter rolls

**** DISMANTLE** the safeguards that prevent felons, illegal aliens, and noncitizens from voting

The Left is a "clear and present danger" to free and fair elections.

They want to make it easier to commit voter fraud, because they think it will make it easier for leftist candidates to win.

And they're right!

One explanation why the Left opposes election integrity is because voter fraud almost everywhere favors leftist candidates.

Senator Cruz understands the danger we're in, and that's why he's joining forces with us to stop voter fraud.

The Left is playing for keeps. The prize is the 2020 elections.

If the Left gets the chance after 2020, they'll rewrite election law to make voter fraud even easier and make it all but impossible for conservatives to ever govern again.

That's why Senator Cruz is enthusiastically supporting Public Interest Legal Foundation's multiple lawsuits around the nation to end the growing menace of voter fraud.

The truth is that voter fraud is a problem that has changed the results in national elections.

* According to a Pew Center study, roughly 24 million -- one of every eight -- voter registrations in the United States are no longer valid or are significantly inaccurate.

* Another study found that enough non-citizen votes had been cast in 2008 to **flip a key Senate seat** and give the Senate Democrats the pivotal 60th vote they needed to pass Obamacare. It also found that it's likely that non-citizen voting pushed North Carolina into Obama's column in 2008.

* An audit of the 2012 elections revealed that 35,570 people voted in North Carolina and another state in the same election.

Dirty voter rolls are an open invitation for voter fraud.

And it has gotten so out of hand that when we sued Broward County, Florida, we found voters on the rolls who were born during Grover Cleveland's presidency -- which ended in 1897!

One of the Left's top priorities is making voter fraud easier and they've proven this by pouring millions of dollars into fighting common sense laws designed to keep ONLY eligible citizens casting ballots.

Recently they have taken it one step further, so that if you even talk about voter fraud, dirty voter rolls, or illegal voting, you are guilty of "voter intimidation".

Just consider this outrageous nugget.

The day before Election Day 2018, a left-wing activist group **formally requested that the Justice Department investigate President Trump**, accusing him of committing "voter intimidation" when he tweeted:

“Law Enforcement has been strongly notified to watch closely for any ILLEGAL VOTING which may take place in Tuesday's Election (or Early Voting). Anyone caught will be subject to the Maximum Criminal Penalties allowed by law. Thank you!”

The Left thinks following the law is "voter intimidation"! They think just talking about voter fraud is voter intimidation.

But the Left doesn't just want to nullify existing voter integrity laws, they want to tear down the ones on our books.

Barack Obama's former Attorney General **Eric Holder** is leading an organization called the "National Democratic Redistricting Committee."

Holder is aiming not only to use redistricting following the 2020 Census to win seats for the Left, but also to kill Voter ID laws in every state.

Mark my words on this...

((If the Left gets the chance after the 2020 elections, they'll change voting laws so completely that our country will be unrecognizable.))

In fact, I was the lead minority witness in the House Judiciary Committee to stop the Left's radical plan to re-write our voting laws.

PILF is determined to save our Republic from the scourge of voter fraud because we believe that the only votes that should count are those of American citizens!

As Senator Cruz wrote, stopping the Left's push for voter fraud will not be easy.

While the 2020 elections may seem far off, the lawsuits we're fighting today will have a direct impact on the results.

And if the safeguards against illegal voting fall, the 2020 elections may be lost before a single vote is cast.

PILF's cases span the country and have included jurisdictions in Florida, Pennsylvania, North Carolina, Texas, Mississippi, and Virginia. In the next two years, we will add other critical states.

We also swiftly take action and **defend election integrity** across the country when attacked by the Left.

For example, we are currently involved in defending Indiana's use of Voter Roll Crosscheck and Nevada's recall procedures and stopping non-citizens from voting in Texas.

We have the nation's most active litigation campaigns on behalf of election integrity.

PILF has also published reports documenting massive flaws in the voter registration systems allowing aliens to register and vote in Pennsylvania, Michigan, New Jersey and Virginia.

→ **We have documented voter rolls riddled with ineligible aliens, felons, and dead people. Some vote and many stay on the rolls for years!**

Through education and aggressive legal action, we're fighting to stop the Left from executing their plan to make voter fraud easier...

...because we can't let our elections be tainted, let alone stolen, by the Left!

Senator Cruz and I are reaching out to you because we both

know we can only stop voter fraud if enough conservatives like you answer the call.


In the days ahead, PILF is going to aggressively hammer the Left on voter fraud in both the court of law and the court of public opinion.
