But I do. President Trump does. And Susan B. Anthony List President Marjorie Dannenfelser does as well.



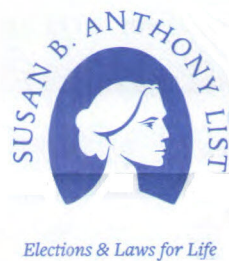
