

→ Here are the facts that led to the Trump-Russia investigation, many of which John Solomon uncovered.

On October 21, 2016, the FBI and DOJ sought and received a FISA probable cause order to spy on Carter Page, who had advised the Trump campaign.

This warrant was renewed three additional times.

When the FBI and DOJ presented the initial application, and with each renewal, they certified that the information that formed the foundation of the warrant was true.

Further, this information was confirmed by officials at the absolute highest levels of the FBI and DOJ.

What was the factual basis of the application to spy on Carter Page?

It was the so-called "Steele Dossier."

**The Steele Dossier was a collection of wild allegations against Carter Page, President Trump, and other people who worked with the president...**

...and it was compiled by a British ex-spy named Michael Steele who was being paid by Hillary Clinton's campaign.

*Talk about a conflict of interest!*

The allegations in the Steele Dossier are unbelievable.

In fact, it's come to light that some FBI officials themselves didn't believe the Steele Dossier.

Top DOJ official Bruce Ohr, who brought the Steele Dossier to his superiors, also told them that its author was employed by the Clinton campaign and had an anti-Trump ax to grind.

Despite Ohr's warnings about political bias, neither the FBI nor DOJ reportedly informed the FISC Court.

In fact, the government said that it knew of no derogatory

information about Michael Steele when the truth is it knew he has provided inaccurate or disproven information in the past.

And just recently the Inspector General of the Justice Department found 17 significant errors in the FISA applications.

This is a **MAJOR SCANDAL** -- and the American public has the right to know if our intelligence agencies have spied on American citizens based on false premises.

The FBI and DOJ attorneys who submitted the warrant to spy on Carter Page may have committed multiple counts of misconduct, including...

- \*\* Knowingly making **false statements** to the Court
- \*\* Knowingly offering evidence the attorney knew was false
- \*\* Knowingly failing to correct a false statement
- \*\* Engaging in conduct that involves dishonesty, fraud, deceit, misrepresentation, or that seriously interferes with the administration of justice

Yet, when we asked the Department of Justice, they told us that **NO ONE** had been held responsible for the phony Steele Dossier and the subsequent bogus investigation of Trump-Russia collusion. That is **TOTALLY UNACCEPTABLE!**

SLF has experience holding the government accountable. We appear over 20 times a year before the U.S. Supreme Court. And we win...

SLF was the organization that filed a bar complaint against President Bill Clinton that led to the surrender of his law license, payment of a \$25,000 fine, and disbarment by the U.S. Supreme Court!

We know how to beat the Left in both courts of law and the court of public opinion.

Our experiment in self-government and our ability to hold people in high offices to account is not up for debate.
