Dear Fellow American Citizen,

I believe we should shut down sanctuary cities and deport dangerous criminal illegal aliens.

Will you act now to help me make this happen?

Please let me know: YES or NO.

Because we have launched litigation designed to end the scourge of sanctuary cities once and for all.

Thanks to sanctuary cities, thousands upon thousands of criminal aliens steal from, rape, and murder innocent Americans every year.

Because sanctuary cities shield criminal aliens from the arm of justice...

...and give criminal aliens special rights -- rights that American citizens don't even have!

Today, I'm not asking you to sign a petition or fill out a survey about sanctuary cities or make any other purely symbolic gesture.

I'm asking you to ACT -- to do the one thing that can get criminal aliens out of our country -- to support SLF's active litigation.

Unlike gridlocked Washington, DC, our litigation is moving through the federal court system right now, and your support can have a measurable impact in moving it forward!

The human carnage caused by sanctuary cities is mounting by the day. I'm thinking of heartbreaking stories like:

* NFL player Edwin Jackson who was **killed after being hit by a drunk-driving illegal alien** who had a blood alcohol concentration nearly three times the legal limit. The illegal alien who killed Edwin Jackson had two convictions

for DUIs in the sanctuary city of San Mateo, California, but wasn't deported.

- * In Philadelphia, another sanctuary city, Milton Mateo Garcia was sentenced to 44 years in prison for raping a young woman. He had been **previously deported**, but was living illegally in the city before he targeted his victim.
- * Nery Estrada-Margos was detained in Sonoma County, California on suspicion of spousal abuse. Immigration and Customs Enforcement (ICE) requested he be detained, but instead he was freed on bail and ICE was given 16 minutes warning. That wasn't enough time for ICE to grab him. Two weeks later Estrada-Margos was arrested for **beating his girlfriend to death**.

Sadly, I have a list much longer than my arm of criminal aliens who have committed heinous crimes thanks to the immunity from deportation that sanctuary cities gave them.

According to ICE, among criminal aliens released in sanctuary cities, 10,000 have committed another crime and roughly 75% reoffend.

This will continue as long as open borders elected officials put the interests of criminal aliens ahead of the rights of American citizens.

This makes me furious!

When did it become acceptable for our elected officials to give criminal aliens special rights?

In effect, these very dangerous people are given a "Get Out Of Jail Free" card when ICE comes knocking wanting to deport them and protect you and me.

Have you ever gotten a "Get Out Of Jail Free" card? I can't even get out of a speeding ticket.

Frankly, it's not possible to go into every liberal jurisdiction and remove criminally negligent officials who twist the law to serve their own warped policies.

And the problem isn't confined to sanctuary cities because sanctuary cities act as safe havens for criminal aliens EVERYWHERE.

So even if you and your family aren't in a sanctuary city, criminal aliens hide there when on the run and then can venture out into the country when they're looking for victims.

It's crazy that some jurisdictions harbor thieves, child abusers, rapists, and murderers. **But they do.**

And don't look to Washington, DC for a fix.

Washington is broken and can't act.

YES, you will join our litigation by enclosing a generous gift of \$25, \$35, \$50, \$100, \$250, \$500, \$1,000 or more...


Or *NO* -- sanctuary cities are someone else's problem.
