** In Colorado, sanctuary city policies led to the death of Tim Cruz at the hands of an illegal alien who was a known gang member.

These jurisdictions only provide sanctuary to criminals, not to victims or to American citizens!

But radical leftist politicians see their support for sanctuary cities as sticking it in the eye of President Trump.

California Governor Gavin Newsom said his state will be a "sanctuary to all who seek it."

Former Chicago Mayor Rahm Emanuel told illegal aliens "You are safe in Chicago. You are secure in Chicago. And you are supported in Chicago. Chicago will always be a sanctuary city."

New York Mayor Bill de Blasio said he would delete a database of 850,000 New Yorkers with a city municipal ID card -- many of whom are illegal aliens -- to stop it from being handed over to the Trump Administration.

And Senate Democrats have filibustered to protect sanctuary cities from losing federal funding.

This is rampant lawless behavior.

And it has real world consequences for people like you and me, my friend.

Sanctuary cities have released over 17,000 dangerous illegal aliens with criminal records into the general public.

These criminal illegal aliens include murderers, rapists, child sex abusers, and drug dealers.

When sanctuary cities let them go scot free, they don't magically turn the corner and clean up their acts. No, the vast majority of them reoffend and commit more heinous crimes.

And yet leftist politicians are putting the welfare of dangerous criminal illegal aliens ahead of your best interests.
