Back in 2012 Congress passed a law-forbidding insider trading called the STOCK ACT —STOP TRADING ON CONGRESSIONAL KNOWLEDGE.

Barack Obama was forced to sign this into law because of the **MASSIVE** public outcry against **career politicians** who used insider information (back then) during the housing crash to trade and get rich while Americans were literally losing their homes.

The law to put these criminals behind bars is on the books. All we need is for you to sign and return to me your **NO PROFITING FROM COVID PETITION** to Attorney Merrick Garland within the next 72 hours so we can start prosecutions.

Remember, back in January and February of 2020, the Coronavirus was confined almost exclusively to China, and the press was reporting to the American public that it wouldn't be coming to the United States.

Then while it spread, the public received conflicting information about treatment options and vaccines. Even today, disinformation about the efficacy of vaccines, effective treatments, and the prognosis of people who catch this disease is rampant.

But while the American public was being kept in the dark, Senators, Congressmen, and their congressional staffs received highly classified information about which drug companies were working on vaccines, about medical technology, and about anything and everything related to the pandemic - AND TRADED ON THAT INFO!

When the government threw millions of dollars at drug companies to develop vaccines that would be marketed and sold TO THE WORLD – the DC Swamp was on the ground floor, learning which companies would be subsidized to develop vaccines and other treatments.

The Swamp swarmed at the chance to profit, like sharks smelling blood in the water. And they used their insider knowledge to trade the stock market. Multiple watchdog groups have targeted close to a hundred lawmakers for potential violations of the STOCK Act.

For example, Assistant Speaker of the House Katherine Clark, D-Mass., is facing a complaint for failing to timely disclose up to **\$285,000 in suspicious medical company trades** – she's the potential successor to Nancy Pelosi, and could be the next Speaker of the House. **But**

instead of putting the people's interests front and center, she was gaming the market to make a windfall for herself.

Democratic National Committee Chairwoman Rep. Debbie Wasserman Schultz of Florida, Senator Mark Kelly of Arizona, Senator Rand Paul, and U.S. Representative Tom Malinowski of New Jersey are just a few of the other lawmakers who jumped on the bandwagon of profiting from insider knowledge about COVID vaccines and treatments.

Rand Paul, the Kentucky senator, and darling of the Libertarian movement, is perhaps the most shocking Senator to come under fire for an ethics complaint. His wife, Kelly Paul bought \$150,000 in stock in Gilead Sciences, which made the medicine Remdesiver. **Remdesiver was later approved for treatment of COVID-19.**

And it's not just vaccines and medical treatments that members of Congress make a profit from. U.S. Representative Tom Malinowski made millions from his stock deals based off insider knowledge before and during the pandemic and global shut downs. **According to Business Insider he bought and sold stocks in Peleton, General Mills, Smuckers, and Chembio Diagnostics, which makes COVID Tests.**

Those lawmakers I mentioned are just the tip of the iceberg. Thomas Suozzi, NY, Rep. Cindy Axne of Iowa, Rep. Warren Davidson of Ohio, Rep. Lance Gooden of Texas, Delegate Michael San Nicolas of Guam, Rep. Bobby Scott of Virginia and Rep. Roger Williams of Texas have also come under recent complaints of potential STOCK Act violations.

And Senators are no better. Tommy Tuberville of Alabama, Blake Moore of Utah, and Pat Fallon of Texas have all been engaged in possible violations of the STOCK Act.

There is an EPIDEMIC of lawmakers who turn insider knowledge into profit!

DRAINING THE SWAMP is STILL a top priority for the American people.


Perhaps even more now that we have seen just how much lawmakers on both sides of the aisle will abuse their privilege of serving our Republic when given the chance.
