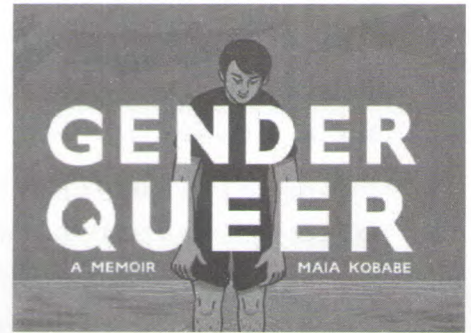
**So why are so many public schools displaying a child pornography book in their libraries?**

Yet hundreds of schools - if not thousands - have a children's book called Gender Queer stashed in their libraries.

The display of this book clearly meets the FBI's definition of child obscenity and distribution laws.

**Here is how the FBI describes child obscenity:**

"Visual representations, such as drawings, cartoons, or paintings that appear to depict minors engaged in sexual activity and are obscene are also illegal under federal law."

**Furthermore, distributing such obscene material to minors is a crime:**

"Federal law strictly prohibits the distribution of obscene matter to minors."

Putting Gender Queer on school library shelves not only meets these legal and criminal standards, but goes beyond!

In just a moment I'll give you the uncomfortable details.

But I can't emphasize enough the importance of returning your enclosed petition, with your name signed next to mine, as soon as possible.

If the public schools want to flood our children's mind with the obscenity found in this book, then we need to flood the FBI with complaints and demands for investigation and prosecution.

That's exactly what this FBI division was set up to do, enforce child obscenity laws. They need to do their job!

Instead of taking our tax dollars to put obscenity into the hands of children, our tax dollars should be used to prosecute those who do!

Believe me, your petition will have an impact.

**In fact, when a mother in North Carolina threatened her local library to remove Gender Queer from their shelves or she'll write a formal complaint to the FBI...**

**...the library removed the book!**

Why? Because it's obvious even to librarians that the book is a violation of federal law. They got caught by this mother and they didn't want to get caught by the FBI.

I really expect and prayerfully hope to see your signed petition returned to me soon.

But as you read on, I want you to know I'm really struggling to report in detail what's in this book.

South Carolina Gov. Henry McMaster called the book "obscene" and said it "easily meets or exceeds the statutory definition of obscenity."

He ordered it removed from the Fort Mill school district.

Elsewhere in Oklahoma, Sen. Rob Standridge proposed legislation to fine school districts \$10,000 for every day that the Gender Queer book remains on its library shelves.

Before describing this book's lurid details, let me explain what the book is attempting to do.

It was written by a female author so that children, especially young girls, will question their "sex assigned at birth."

Now, I know you're probably asking, "What in the world is meant by 'sex assigned at birth?'"

It means four things:

1. God did not create people either male or female.
2. Having male or female sex organs does not determine a person's sex.
3. Sex is a temporary assignment made by a parent or a doctor.

**...the book guides children into the reasons to doubt - and ultimately reject! - their God-given birth gender.**

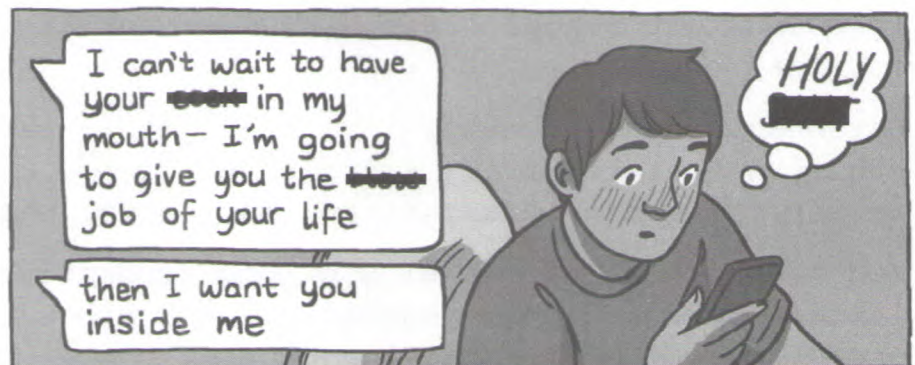
The book follows the real-life experience of a young girl who grew up hating the idea that she would grow breasts, have menstrual cycles, endure gynecological exams and not have a penis.

She tells her story in graphic detail using cartoon imagery.

*"I was 11 or 12 years old the first time I can remember fantasizing about having a penis," she writes, while depicting herself grabbing and squeezing her groin area.*

She then graphically depicts her fantasy of watching two naked men on a bed kissing and having sex.

And if that's not crude enough, she then shows a drawing of her masturbating while driving a car, saying she is imagining herself getting oral sex from a man.



This is one of the tamer images in the Gender Queer book being stocked in school libraries! I blacked out the more offensive words.

I know these details are difficult to process, but I promise that I'm giving you the 'cleanest' version possible to describe the actual profane words and pictures found in this explicit book.

**She not only talks about having oral sex with others, but of actually having oral sex on herself!**

**"So you never tasted yourself?" a friend asks, trying to goad her into performing the act.**

How is any of this appropriate for school-aged children? Why would a single tax dollar be spent shelving this book in ANY library, much less a school library?

And how is any of this legal?

In one drawing, there is an X-rated picture of a boy performing oral sex on her while she wears an artificial penis.

Not only are schools promoting child pornography with this book in their libraries, (a criminal act by itself), but they are putting this obscene material in front of children, which is also a crime.

Let me repeat the words found on the FBI's website, written by Agent Steven J. Grocki, that makes all of this a federal crime:

**"Federal law strictly prohibits the distribution of obscene matter to minors."**

**AND...**

**"Visual representations, such as drawings, cartoons, or paintings that appear to depict minors engaged in sexual activity and are obscene are also illegal under federal law."**



According to YOUR OWN words, Agent Grocki, the distribution of this book constitutes a federal crime.

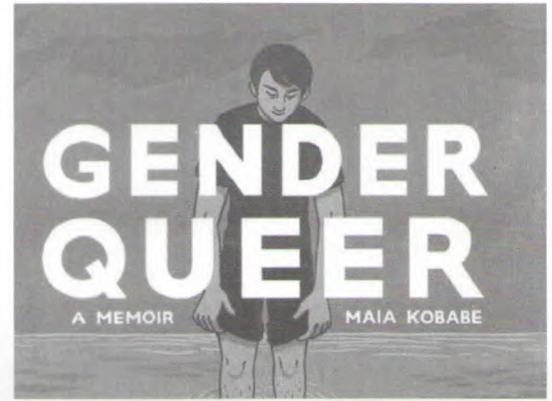
Here is how YOU describe child obscenity:

"Visual representations, such as drawings, cartoons, or paintings that appear to depict minors engaged in sexual activity and are obscene are also illegal under federal law."

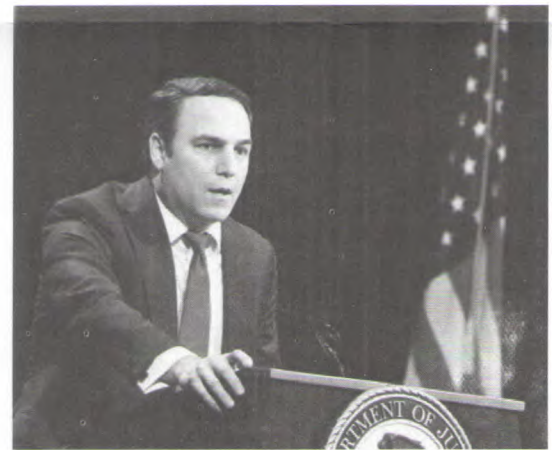
Here is how you describe the crime of distributing obscenity to minors:
