I'm Bob Barr. I'm a former Federal Prosecutor, Georgia Congressman, and Presidential candidate. I place my trust in the United States Constitution and the good sense of the American People.

In my professional career I have stared down the leaders of drug cartels, con artists and corrupt government officials and I am proud of my role as a House Manager in the impeachment trial against that most disgraced of Presidents, William Jefferson Clinton.
