How can we hope to fight back when the most powerful, most influential, and most wealthy institutions in American society are arrayed against us?

I'll tell you how!

We start by telling the truth. We continue by proving it. And then we end this nightmare by defeating the Pro-Fraud “cabal” in Washington so it never happens again.

And that's why I've been fighting alongside my good friend Senator Doug Mastriano to demand a rigorous **statewide Forensic Audit** of the 2020 election here in Pennsylvania.

If Doug's name rings a bell, you may know him as the Pro-Trump “Gettysburg Colonel” who defied the Washington Swamp and the Fake News by holding a 4-hour hearing to examine evidence and testimony of widespread election “irregularities” in 2020.

Now before I get into the details of what Sen. Mastriano and I are fighting for – as well as my own plans to Drain the Swamp if elected to Congress with your help – I'll give an overview of the biggest, baddest red flags of the 2020 election:

In fact, **Sleepy Joe lost black and Hispanic voters to President Trump** in almost every city and state that wasn't absolutely necessary for his “victory”.



President Trump won larger shares of the black and Hispanic vote than any Republi-

can in over 60 years – something that should have spelled doom for Biden!

But in the specific jurisdictions where corporate leftists “donated” hundreds of millions directly to the payrolls of election officials, Biden outperformed even Barack Obama’s record!

Many of these precincts reported more votes than they had registered voters!

How did this happen? The short story is that Democrats neutered election security protections across the country, while simultaneously pushing **Cheat-By-Mail!**



In the past, many jurisdictions rejected mail-in votes at a rate of 5-20% due to strong security rules. In 2020, rejection rates cratered to less than 1% in almost every state.

Independent analysis found that the difference in **Cheat-By-Mail** rejection rates

between 2016 and 2020 by itself accounts for almost all of Biden's "winning" votes.

In Pennsylvania alone, a survey matched exact birthdates and full names with obituaries to identify over 40,000 "graveyard caucus" votes from **dead American citizens**.

In addition – despite Pennsylvania law being clear that no ballots should be accepted after Election Day, nearly 200,000 suspicious votes were being counted up to a *month* after Election Day in Pennsylvania. Biden's "margin of victory" was less than half that number.

One partial review found thousands of fake voter registrations claiming to be "living in" P.O. Boxes as well as UPS and FedEx locations.

In one embarrassing episode, an Anti-Trump election official admitted that an out-of-state resident had illegally cast a fraudulent **Cheat-By-Mail** vote using his own home address!

These facts alone justify a **statewide Forensic Audit** in Pennsylvania!

Not a single one of these facts is disputed– despite blanket statements by the Fake News, Swamp politicians, and Establishment bureaucrats that there was "no fraud".

**The *only* plausible explanation for this is fraud.**

In other words, there are almost four million "extra" votes that the U.S. government can't account for by talking to living, breathing human beings.



So I don’t think it’s a coincidence that Democrats in Pennsylvania... aided by the half-billion-dollar Big Tech Socialist money machine I told you about... pulled every dirty trick in the book to keep legally-authorized poll watchers from observing the election AND to stop enforcing virtually all election security protections.

**THEY ALSO CENSORED DOUG + THE PRESIDENT!**

You probably heard about the testimony of retired Army Colonel Phil Waldron, who testified about suspicious “spikes” in the vote count...

You might even remember the loud gasp from the audience when he said that these “spikes” accounted for about 600,000 votes... and **about 95% of them went for Biden.**

This allegation alone justifies an immediate intervention to ensure that we have a rigorous **statewide Forensic Audit** in Pennsylvania! Now that was the big story to come out of the Gettysburg Election Integrity Hearing, but very few people have heard something that I believe is even more disturbing.

Several witnesses described a concerted effort on behalf of corrupt election officials

and the Democrat partisans who own them to illegally deny access to certified poll watchers.

Election Integrity in America rests on one thing above all... it's not computers or paperwork or promises from politicians... it's sworn witnesses to the election count!

And three witnesses – backed up by video evidence – testified that all observers were fenced off and kept between 15-200 feet away from the counting of ballots in Philadelphia. This gave “zero opportunity for observers to observe, challenge, or inspect” the votes.

Also in Philadelphia, one witness testified about how he and many other Republican poll watchers were denied access to polling places. At one such polling place – located at a funeral parlor (**I'm not joking!**) – election officials asked him to “step outside” and they physically threatened him... while a journalist caught it all on camera.

In Delaware County, the entire ballot-counting warehouse operation was run by a Democrat Socialist with no relevant experience – except being a Bernie Sanders delegate. He flatly refused to allow any legally-certified poll watchers to witness the count.

So, as two witnesses testified, they sued the County for a court order to get legally-mandated access. The judge – a left-wing hack – only ordered the Democrat Socialist election official to give the poll watchers access for **just five minutes every two hours**.

Three days after Election Day, two poll watchers – one Republican... one Democrat... both forensics experts – well, **they witnessed something remarkable...**

In a locked back-room of that busy warehouse, while the County attorney stood with a stopwatch set for 5 minutes, they saw one man in a room with a sorter machine and between 60,000-70,000 *unopened* mail-in ballots. This was supposedly *after* the count had already been mostly completed, with “only 6,000” votes left to count.

The next time they got their 5-minute window, those tens of thousands of unopened ballots had mysteriously disappeared and **nobody can explain why**.

Later it was revealed that “virtually all chain of custody logs, records, yellow sheets, everything, was gone. All forensic evidence... in Delaware County [was] gone.”

You'd think that the courts would have had something to say about all this... but despite plenty of evidence and hundreds of witnesses, our courts ruled that:

- Just because our law says that election observers must be provided access, doesn't mean that they're entitled to “**meaningful access**”
- Every election security law can be ignored at will in an “**emergency**” like COVID

Now all that I've told you so far – which is just a drop in the bucket – isn't proof

positive that criminal fraud happened here in Pennsylvania. But it is proof positive that the **election in Pennsylvania was illegitimate**.

So the 2020 election was illegitimate. Joe Biden was not elected. He was installed.

And, if you ask me, it is practically criminal that the RINO hacks in the Swamp Establishment haven't bothered to demand a **statewide Forensic Audit** so we can find out!
