An individual may not contribute more than a total of \$2,900 (maximum for Primary Election) and a total of \$2,900 (maximum for General Election) per election cycle to the committee. Federal law prohibits contributions to the committee from the general treasury funds of a corporation, labor organizations or national banks (including corporate or other business entity credit cards), from any person contributing another's funds, from a Federal government contractor, or from a foreign national who lacks permanent resident status.
